All competitors must understand, agree and consent to the following (if under 18 years of age a parent or legal guardian must also agree & sign the form):

- I understand that BMX, Scooting, Skateboarding & Inline Skating are hazardous sports & can be dangerous & that I therefore compete at my own risk.
- I accept that **I must wear an approved helmet** for safety (a few will be available on the day) & if I do not wear a helmet I cannot compete. I accept that the organisers strongly recommend that I wear full protective clothing i.e. kneepads & elbow pads.
- I accept that I am responsible for my own equipment & its proper use & suitability.
- I agree to be respectful of others on the day & to behave in an orderly, safe & considerate manner & follow any requests or instructions by competition organisers.
- I agree that verbal abuse, swearing, fighting/ reckless behaviour, littering or the use of alcohol or illegal drugs are prohibited & will result in disqualification with no refund.
- I agree that in the event of sustaining an injury or becoming ill during the competition there are trained members of staff in attendance (St Johns Ambulance) who can provide medical assistance &/or obtain outside medical help for an injured participant provided that the staff have been given consent to do so by the participants parent/ legal guardian. Therefore by signing the consent form below I am accepting that Bradley Stoke Town Council shall not be held liable for any acts, omissions or adverse results of any medical treatment administered to the participant.
