- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Council Offices, Castle Street, Thornbury, South Gloucestershire, BS35 9TX by **5 pm on Tuesday, 28th April 2015**.
- Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after **5 pm on Tuesday, 28th April 2015**, must reach the Electoral Registration Officer at Council Offices, Castle Street, Thornbury, South Gloucestershire, BS37 5AF by **5 pm on Thursday, 7th May 2015**.
