Surfacing of Bradley Stoke Way

We are coming towards the conclusion of the construction works on Bradley Stoke Way between Aztec West and Patchway Brook Roundabouts.

Following progress ahead of schedule before Christmas we are able to bring forward final surfacing of the road (previously planned for mid- February). This will now commence on **Wednesday 11th January for a period of 3 to 4 weeks**. We will be working together at times with the South Gloucestershire Signalisation team who will be installing the traffic signals and loops in the area in preparation for final opening.

The surfacing will involve elements of daytime working with off-peak lane closures and night time working with full closures (as previously advertised). However, the main full closures will either be Aztec to Woodlands Lane OR Woodlands Lane to Aldi Roundabouts so as to keep through traffic flowing as best as possible using Pear Tree Road.

We will also require a full weekend closure between Woodlands Lane and Aldi Roundabout during the period to address the full reconstruction at Aldi roundabout. The date of this will be dependent on weather but will be from Friday at 8pm until Monday at 4am. Please note that we will be erecting advanced warning signs for periodic night/weekend closures from 16th January before the end of this week to give notice.

Laying of hot tarmac on the top road surface is very dependent on dry weather and cannot be laid during freezing temperatures. Light rain is manageable but not prolonged heavy rain. Adverse weather conditions may cause a postponement.

We will contain the noisier elements of milling the top surface in preparation for the final layer of tarmac for day time or early evening to minimise disturbance where we can. There will still be some noise disruption with night time work.

We will maintain access to residents at Orchard Gate at all times.

Apologies for any disruption and delays caused throughout this period of essential work and thank you for your continued cooperation and assistance as we work towards the conclusion of our works in this area.

Finally, a Public Meeting has been arranged to discuss the continuing MetroBus Roadworks Bradley Stoke Way on **Thursday 12th January 2017 7:00 – 8:30pm: Baileys Court Activity Centre, Baileys Court Road, Bradley Stoke**. The meeting will consist of a presentation regarding the remaining road works on Bradley Stoke Way and the implications for residents and commuters followed by a question and answer session.
